Honor Cremations believes that pricing for local cremation services should be simple and transparent with no hidden fees or overwhelming decisions. Our high-quality, simple cremation plans include 24-hour support from our compassionate professionals, transportation from the place of passing to Honor Cremations, sheltering in a secure climate-controlled environment until the date of cremation, an environmentally-friendly cremation container, the private cremation itself and a dignified wood urn.

The Redwood Cremation Plan: Starting at \$1,700

Designed to provide all Honor's essential cremation services. Once the cremation is completed, a scheduled time is determined to receive the urn and death certificates from the Honor Office. All taxes and permit fees are included.

The Honor Cremation Plan with Domestic Mailing of the Urn: Starting at \$1,925

Honor Cremations allows for mailing of the urn to any United States residence or cemetery. Once the cremation is completed, Honor Cremations will carefully package the urn for mailing through the United States Postal Service. Once the urn is scheduled for mailing, the client-family will be notified in the Honor Hub and will be provided tracking information. All taxes and permit fees are included.

The Honor Cremation Plan with Local Hand-Delivery of the Urn: Starting at \$1,925

Honor Cremations offers a courier service for delivering the urn to a selected local residence or cemetery. This means that the urn is delivered by vehicle directly from Honor Cremations without passing through the mail. The date and time of courier delivery will be selected by the client-family within the Honor Hub once the cremation is completed. All taxes and permit fees are included.

The Pacific Cremation & Scattering Plan: Starting at \$2,210

Honor Cremations offers a scattering service for client-families wishing to scatter ashes in the San Francisco Bay. Once the cremation is completed, Honor Cremations will work directly with a local boat captain to perform the scattering in a dignified manner. Based on weather conditions, the boat captain will determine the most appropriate date for scattering and the client-family will be notified in advance within the Honor Hub. Once the scattering has taken place, photographs taken by the boat captain will be provided in the Honor Hub and a certificate of scattering will be sent by mail. All taxes and permit fees are included.

The Pacific Plan with Attended Scattering at Sea: Starting at \$2,660

Honor Cremations offers the ability for families to hold a scattering ceremony aboard a private boat charter in the San Francisco Bay. Our team will coordinate the date and time with the Boat Captain and deliver the urn prior to the family's arrival at the dock. Attended scattering ceremonies leave from Sausalito in Marin County and last approximately 1.5hrs. Attendance is limited to six guests. All taxes and permit fees are included.

The Honor Plan with a Memorial Service: Starting at \$3,175

Honor Cremations offers the ability for families to gather for a memorial service or celebration of life at a local church that Honor Cremations partners with or the local church of your choosing. Memorial service gatherings last 1.5-hours and families have the option of having their loved-one's urn present. All taxes and permit fees are included.

The Honor Plan with Family Viewing at Crematory and Witness Cremation: \$3,417

Honor Cremations offers the ability for families to spend time with their loved-one and be present at the start of the cremation. Our team will work with you to select the best date and time for the 45-minute private family viewing, held in the covered, outdoor viewing space at Irvington Memorial Crematory just prior to the start of the cremation. All taxes and permit fees are included.

The Honor Plan with Witness Cremation: \$3,157

Honor Cremations offers the ability for families to be present at the start of the cremation. Our team will work with you to select the best date and time for the 45-minute private family time (viewing not included), held in the covered, outdoor chapel at Irvington Memorial Crematory just prior to the start of the cremation. All taxes and permit fees are included.

The Honor Plan with Family Viewing at Local Church: \$4,372

Honor Cremations offers a simple option for families wishing to see their loved one and hold a gathering in a more traditional space prior to the cremation. Our team will work with you to select the best date and time for the 2-hour viewing and service held at a local church that Honor partners with or the local church of your choosing. All taxes and permit fees are included.

The Honor Plan with Family Viewing at Church and Witnessed Cremation: \$4,722

Honor Cremations offers a simple option for families wishing to see their loved one and hold a gathering in a more traditional space prior to the cremation. Our team will work with you to select the best date and time for the 2-hour viewing and service held at a local church that Honor partners with or the local church of your choosing. Following the service, a witness cremation will take place at Irvington Memorial Crematory. All taxes, permit fees and one Certified Death Certificate included.

Tranquility Water Cremation Plan (Hydrolysis): \$3,870

Honor Cremations offers gentle eco-friendly water cremation providing all Honor's essential services. Once the water cremation is completed, a scheduled time is determined to receive the urn and death certificates from the Honor Office. All taxes and permit fees are included.

Itemized Goods and Services

Basic Services of Funeral Director and Staff, and Overhead: \$662

This fee is for our basic services and overhead. It will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremation). This fee includes responding to the initial request for service; conducting the arrangement conference; preparing the biographical and statistical data; preparing and filing papers, permits and authorizations; coordinating with those providing other services; and retaining and caring for remains prior to commencement of post-death activities.

Transportation

Transportation of Remains to Funeral Home: \$400

Honor Cremations performs transportation from all counties in California and charges a flat fee for decedents within Alameda, Contra Costa, San Francisco, San Mateo, Santa Clara, Santa Cruz & Stanislaus Counties.

Immediate Burial: \$2,499-\$3,449

Includes the basic services of a funeral director and staff, collection of the decedent from a residence, hospital, coroner's office, nursing home or funeral home to the funeral home, sheltering the decedent in refrigeration for up to 10 days including the day the decedent was brought into Honor Cremations' care, dressing and casketing, funeral hearse and use of equipment and staff for a direct burial. All taxes, permit fees and one death certificate included.

Direct Burial with Casket Provided by Purchaser: \$2,499

Direct Burial with The Honor Casket: \$3,699

Direct Cremation: \$1,677-\$2,787

Includes the basic services of a funeral director and staff, collection of the decedent from a residence, hospital, coroner's office, nursing home or funeral home to the funeral home, sheltering the decedent in refrigeration for up to 10 days including the day the decedent was brought into Honor Cremations' care, an alternative cremation container, transportation to and from the crematory, basic urn suitable for selected disposition, receiving of the urn by the family from the Honor Offices, and crematory fee. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are fiberboard.
